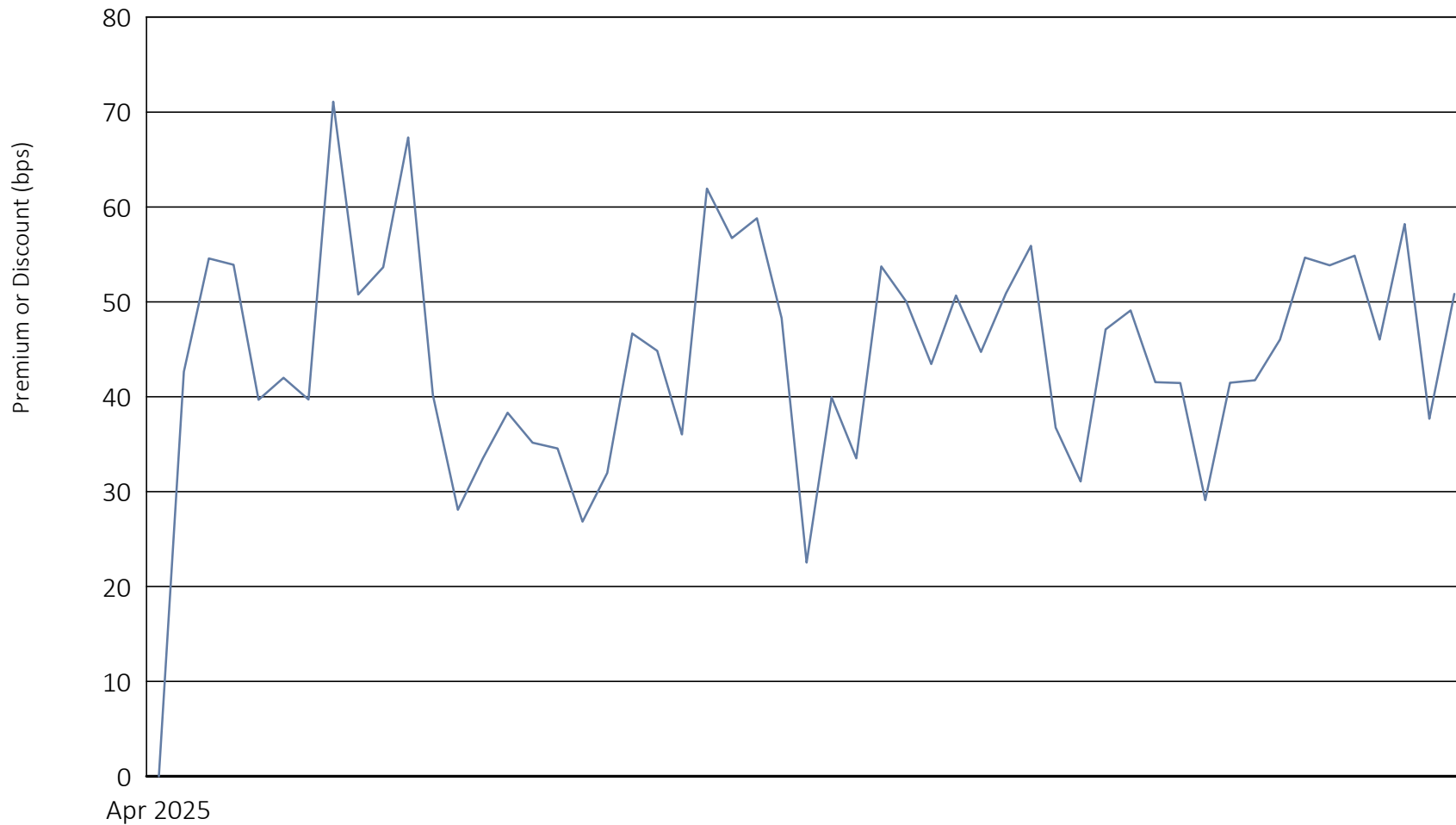


## F/m High Yield 100 ETF
