# A US Treasury ETF Designed to Equitize the 20-Year US Treasury

# **Single Bond ETF**

## **Why UTWY**

- UTWY aims to provide exposure to the current US 20-Year Treasury Bond, with the ease and efficiency of an ETF.
- UTWY aims to make monthly dividend payments, more frequent than those of the underlying security.
- Minimize transaction costs and the operational burden required to continually roll to the new US Treasury Security as it is issued - and enjoy the potential tax efficiencies of an ETF.

#### **INVESTMENT OBJECTIVE**

UTWY is a passively managed, single-bond fund that invests in the most recently issued on-the-run 20-year US Treasury bond. The fund will seek investment results that correspond (before fees and expenses) generally to the price and yield performance of the Bloomberg US Treasury Bellwether 20Y Total Return USD Unhedged Index.

### **Underlying Bond:**

The US Treasury auctions a new 20-Year Treasury bond each quarter. The auction will determine the coupon rate of each new on-the-run¹ bond. Once the auction is complete and can be settled, UTWY will sell the currently held, old 20-Year US Treasury and roll into the newly issued 20-Year US Treasury.

It is computed by dividing the net investment income per share earned during the period by the maximum offering price per share on the last day of the period. The figure listed lags by one month.
