Why UTHY

- UTHY aims to provide exposure to the current US 30-Year Treasury Bond, with the ease and efficiency of an ETF.
- UTHY aims to make monthly dividend payments, more frequent than those of the underlying security.
- Minimize transaction costs and the operational burden required to continually roll to the new US Treasury Security as it is issued - and enjoy the potential tax efficiencies of an ETF.

INVESTMENT OBJECTIVE

UTHY is a passively managed, single-bond fund that invests in the most recently issued on-the-run 30-year US Treasury bond. The fund will seek investment results that correspond (before fees and expenses) generally to the price and yield performance of the Bloomberg US Treasury Bellwether 30Y Total Return USD Unhedged Index.

Underlying Bond:

The US Treasury auctions a new 30-Year Treasury bond each quarter. The auction will determine the coupon rate of each new on-the-run¹ bond. Once the auction is complete and can be settled, UTHY will sell the currently held, old 30-Year US Treasury and roll into the newly issued 30-Year US Treasury.

¹ New On-The-Run refers to the periodic transition to the most-recently auctioned Treasury bill, note, or bond of a stated maturity, which is referred to as the "on-the-run" or "OTR" security of that maturity, occurs on one day. Bloomberg US Treasury Bellwether 30Y Total Return USD Unhedged Index: is a one-security index comprised of the most recently issued 30-year US Treasury bond. The index is rebalanced monthly. In order to qualify for inclusion, a 30-year bond must be auctioned on or before the third business day before the last business day of the month.

Duration is a measure of the sensitivity of the price of a bond or other debt instrument to a change in interest rates.

30 Day SEC Yield: Based on a 30-day period ending on the last day of the previous month. It is computed by dividing the net investment income per share earned during the period by the maximum offering price per share on the last day of the period. The figure listed lags by one month. When a dash appears, the yield available is not available yet.
