##### Why UTWO

- UTWO aims to provide exposure to the current US 2-Year Treasury Note, with the ease and efficiency of an ETF.
- UTWO aims to make monthly dividend payments, more frequent than those of the underlying security.
- Minimize transaction costs and the operational burden required to continually roll to the new US Treasury Security as it is issued - and enjoy the potential tax efficiencies of an ETF.

#### INVESTMENT OBJECTIVE

UTWO is a passively managed, single-bond fund that invests in the most recently issued on-the-run 2-year US Treasury note. The fund will seek investment results that correspond (before fees and expenses) generally to the price and yield performance of the Bloomberg US Treasury Bellwether 2Y Total Return USD Unhedged Index.

#### Underlying Bond:

The US Treasury auctions a new 2-Year Treasury note each month. The auction will determine the coupon rate of each new on-the-run<sup>1</sup> note. Once the auction is complete and can be settled, UTWO will sell the currently held, old 2-Year US Treasury and roll into the newly issued 2-Year US Treasury.

**30 Day SEC Yield:** Based on a 30-day period ending on the last day of the previous month. It is computed by dividing the net investment income per share earned during the period by the maximum offering price per share on the last day of the period. The figure listed lags by one month.
